

SUPREME COURT CASE ESSAY ASSIGNMENT

Directions: The student will choose 5 Supreme Court cases to research and then write an essay about each of the five cases (i.e. five separate essays). Each essay will summarize the case and explain why it is significant. Students may choose any U.S. Supreme Court case from 1791 to the Present. **No plagiarized work will be accepted.**

All 5 essays must be completed according to the following requirements:

- The essay must be typed, double-spaced, Times New Roman, font size 12, 250 word minimum.
- Sources must be properly cited at the end of the essay.
- The student will describe the case in a **5 paragraph essay** which includes answers to the research questions: Who, What, Where, When, Why and How (see below for details).
 - **Introductory Paragraph:** Briefly describe the name of the case, when it was heard, identify the parties involved, and briefly introduce the controversy or focus of the case.
 - **Main Body (3 paragraphs)**
 - **1st Paragraph** - Explain the details of the controversy/question in the case.
 - **2nd Paragraph** - Explain the history of the case: Where did the case begin; what court had original jurisdiction, and how did it move through the court system? When did the case originally begin, and when did the Supreme Court make its decision?
 - **3rd Paragraph** – What was the Supreme Court’s decision in the case? What was the majority’s opinion, and what was the minority’s opinion?
 - **Concluding Paragraph:** Briefly restate the case and the court’s decision. Then, answer the following question: How does the Supreme Court’s ruling in this case affect Americans today?

The student may research any U.S. Supreme Court case. Some suggested cases include (but are not limited to): *Marbury v. Madison*, *McCulloch v. Maryland*, *Gibbons v. Ogden*, *Dred Scott v. Sanford*, *Plessy v. Ferguson*, *Gideon v. Wainwright*, *Miranda v. Arizona*, *Roe v. Wade*, *Mack v. U.S.*
